11/331 **MOTION**

Notice of motion received from Cllr A Wilkes on 21st October 2025: Standing Order s9

The Council will debate the following motion:

Title of Motion

Broadcasting of Yeovil Town Council Meetings

Purpose of the Motion

To consider a proposal for Yeovil Town Council to begin the recording and broadcasting of its Full Council and key Committee meetings, in order to enhance transparency, accessibility, and public engagement.

Background

Many Councils, including Somerset Council and comparable town councils such as Weston-Super-Mare and Frome, now routinely live-stream their meetings via an online platform (such as YouTube or Facebook) to improve public participation and transparency.

Yeovil Town Council already welcomes public attendance and allows meetings to be filmed under its Standing Orders. Under Standing Order 3(n), members of the public are permitted to film, photograph, or record Yeovil Town Council meetings that are open to the public.

However, there is currently no provision for the Council itself to broadcast or publish video recordings of meetings.

Officially recording and broadcasting meetings could improve the perception that Yeovil Town Council is dedicated to:

- increasing transparency and trust in Council decision-making;
- enabling broader participation and accountability; and
- to align Yeovil Town Council with modern local-government communication standards, as already adopted by Somerset Council and neighbouring authorities.

This proposal seeks to bring Yeovil Town Council in line with that best practice, using an initial pilot to test feasibility, cost, and community benefit.

Proposal (Motion)

That Yeovil Town Council:

- 1. Agrees in principle to record and broadcast Full Council meetings and key Committee meetings (including Finance & Policy Executive and Planning) via an accessible online platform such as, but not limited to YouTube or Facebook;
- 2. Requests the Chief Executive/Town Clerk to prepare and report back to this Committee on:
 - technical options and indicative costs for live-streaming and/or recording;
 - data-protection, safeguarding, and consent considerations;
 - · recommended storage and publication arrangements for recordings; and
 - any required updates to Standing Orders or the Social Media Policy;
- Once the report within (2) has been approved, to approve a three-meeting pilot programme for live-streaming Full Council meetings, following which this Committee will review outcomes and determine whether to adopt broadcasting as standard practice; and
- 4. Once the report within (2) has been approved, to confirm that recordings will form part of the official public record of the meeting in accordance with the Openness of Local Government Bodies Regulations 2014, and that all attendees will be notified at the start of meetings that recording and broadcasting is taking place.

Financial Implications

To be determined following the Chief Executive/ Town Clerk's report on technical options and potential costs.

Indicative costs for basic streaming equipment and platform setup are expected to be low to moderate and could be funded from the existing Communications or ICT budget.

Legal and Policy Implications

Standing Orders currently allow public filming but do not address council-led broadcasting.

The Openness of Local Government Bodies Regulations 2014 and Data Protection Act 2018 must be observed.

A minor update to the Social Media Policy and Standing Orders (Section 3) may be required to authorise official recording by the Council.

Recommendation

That the Council **RESOLVES** to approve the motion as set out above and instructs the Chief Executive/Town Clerk to prepare a detailed report with costings and policy recommendations for implementation of a live-streaming pilot.
