# 11/025. APOLOGIES FOR ABSENCE AND TO CONSIDER THE REASONS GIVEN

Apologies for absence (LGA 1972 s85(1)) were received from Cllrs J Lowery (conflicting engagement) and L Watts (work commitments).

### 11/026. DECLARATIONS OF INTEREST

There were no declarations of interest.

### 11/027. MINUTES OF LAST MEETING

The Committee approved as a correct record the Minutes of the previous meeting held on 12<sup>th</sup> July 2022 (the meeting scheduled for 13<sup>th</sup> September was cancelled).

**RESOLVED:** That the Minutes of the meeting of the Promotions and Activities Committee held on 12<sup>th</sup> July 2022 be signed by the Chairman as a correct record.

### 11/028. CHRISTMAS LIGHTS AND CHRISTMAS LIGHTS SWITCH ON

Following being made aware of proposal by Steve Haigh (Radio Ninesprings), the Committee agreed to move this agenda item to the end of the meeting. Due to the (now) confidential nature of the business of item 11/028 under the Public Bodies (Admission to Meetings) Act 1960 s3, a motion to exclude members of the public and press during discussion of this item will be considered by the Councillors. *Public Bodies (Admission to Meetings) Act 1960 s3* 

**RESOLVED:** to move this agenda item to the end of the meeting.

## 11/029. SUPER SATURDAY

The Committee considered the verbal report from the Deputy Town Clerk. The event which was due to take place on 17<sup>th</sup> September had been postponed due to the sad death of Her Majesty Queen Elizabeth II. The new date is Saturday 10<sup>th</sup> December 2022.

The plans still include the following: eat:festivals, circus skills, stilt walker, walkabout act, buskfest, balloon modeller and local community stalls, however availability of some of the participants was yet to be confirmed.

It was explained that there would still be some restrictions on the areas of the town available for use this year due to Yeovil Refresh. Some of the budget had been used on advertising the September Super Saturday and paying cancellations fees for the event.

**RESOLVED:** (1) to note the report; and (2) to note the new date for the event.

### 11/030. FUTURE EVENT PROPOSAL

The Committee considered the report by the Deputy Town Clerk and it was agreed that a two-day celebration event take place in May 2023.

With regard to charging for a "party in the park" style event, the Town Clerk reminded the Committee that the bands/performances were reasonably priced as they were supporting a community/charity event.

The Deputy Town Clerk reminded the Committee that they had considered the following future events at the last meeting:

- Armed Forces Day (next year)
- A similar event to "Yeovil Celebrates The Queen's Platinum Jubilee" (next year)
- Country music festival (this financial year)

- Picnic in the park every year
- Assist Yeovil Together
- Regular events in The Triangle
- 40<sup>th</sup> anniversary of Yeovil Town Council

**RESOLVED:** (1) to hold a "*Yeovil Celebrates... The New King*" event on 27<sup>th</sup>/28<sup>th</sup> May 2023; and (2) that a revised cost for a two-day event be referred to the Policy, Resources and Finance Committee for confirmation of expenditure and inclusion in the 2023/2024 budget.

## 11/031. EAT:FESTIVALS 2023

The Committee considered the proposed dates for eat:festivals to come to Yeovil in 2023 and the associated cost.

**RESOLVED:** (1) that eat:festivals return for three events in 2023: 22<sup>nd</sup> April, 16<sup>th</sup> September and 9<sup>th</sup> December; and (2) that it be noted that the associated costs are included within the Promotions and Activities budget.

### 11/028. CHRISTMAS LIGHTS AND CHRISTMAS LIGHTS SWITCH ON

The Deputy Town Clerk read out an email regarding the Christmas Lights which suggested that given the national need to save energy it be considered whether the town should have Christmas Lights this year and if so, whether they should only switched on for short periods of time.

**RESOLVED:** that the Christmas Lights available (which may be reduced due to the Yeovil Refresh works) be switched on.

The Deputy Town Clerk read out a letter from Love Yeovil regarding the Christmas Lights Switch-on event which proposed that Love Yeovil organise the event.
