#### Planning Committee – 30<sup>th</sup> May 2022 and 20<sup>th</sup> June 2022

Presented by Cllr Graham Oakes. He gave an update regarding the Planning Committee meetings. There were no questions.

#### Promotions and Activities Committee – 14<sup>th</sup> June 2022

Present by Cllr E Hopkins. She spoke of the successful Queen's Jubilee Event held at Yeovil Recreation Ground, the financial support of £2,000 for the Yeovil Together event, the support for Yeovil Arts Action Group and the Jubilee Lighting event. Other Councillors also spoke of the success of the Jubilee Event and thanked the team involved as well as the contribution of the Councillors. It was estimated that about 7,000 people attended the event. A round of applause was given to the team.

# Grounds and General Maintenance Committee – 13<sup>th</sup> June 2022

Presented by Cllr Royston Spinner. Discussions were held regarding the upgraded skate parks (deferred until a future meeting), open spaces and electing a co-opted member. There were no questions.

#### **Buildings and Civic Matters Committee – 21<sup>st</sup> June 2022**

Presented by Cllr Rob Stickland. He spoke of the presentations by both the police and Yeovil Crime Reduction Team. He gave an update on the defibrillator projects and thanked both the Town Clerk and Yeovil Press for their contributions. He also spoke of the proposed Changing Place at Peter Street Public toilet. There were no questions.

### Policy, Resources and Finance Committee – 28<sup>th</sup> June 2022

Presented by Cllr Graham Oakes. He spoke the grants that had been awarded to three organisations. He updated the Council on the financials. He also spoke of the Service Level Agreement (SLA) with Yeovil Art Space and of the opportunities it could bring. There were no questions.

#### 11/026 MOTION FROM CLLR G OAKES

**RESOLVED:** to agree the following, "The war in Ukraine has led to countless deaths and injuries. It forced millions of people to leave their homes and flee to neighbouring countries. A small number of refugees have arrived in Yeovil, and they are welcome. This Council will make a donation of £5,000 to help refugees from the Ukraine, here in Somerset to an appropriate body."
